## ASPEN MINE CENTER CELEBRATES 10TH ANNIVERSARY

If you haven't seen the inside of the Aspen Mine Center yet, why not? You've had 10 years to check it out! There are many reasons to do so. It's a beautiful building, thanks to the original owners. It even has its own waterfall. There is a great coffee shop and café with wi-fi. Primarily it is the home of the Community of Caring Foundation, Teller County Salvation Army, and two dozen other service agencies and nonprofits, with many more agencies and nonprofits as affiliates.

The AMC is a one-stop resource and referral shop. In its existence, it has served thousands of people and families. It has provided \$842,000 of assistance and 620,000 pounds of food. Founder Mary Bielz has handed out 50,000 pounds of candy and volunteered 26,000 hours of her time. Among the more popular and visible programs are our food pantry, clothes closet, Golden Circle hot lunches, commodities, Pikes Peak Workforce Center and Teller County social services. Our collaborative program with our local school district, the Mountain Alternative School, has

served 722 students and has a 94% core student graduation rate.

The Center began life as the Aspen Mine Casino, which

closed in the mid-90s; the building sat empty for a few years. Art teacher Bielz, who had been running a Community of Caring program from her school classroom, and local realtor Reed Grainger, approached the owners to ask if they might donate the building. They said, Yes if we had 501c3 status. As Bielz had acquired that status, the building was donated and the Center was born, 10 years ago this year.

## TRANSPORTATION PLAN MOVES TOWARD FINISH LINE

"We're rolling! We're moving! The rubber is meeting the road! A 3-year effort to provide transportation between Cripple Creek and Victor is imminent and could be a reality at the beginning of 2013," said transportation task force members, Mary Bielz and Victor councilwoman Veldean Petri.

"This effort at achieving a coordinated transportation system first phase is the extension of the Cripple Creek shuttle to Victor. By now, all of you have taken part in a survey or two. The results are an overwhelming support for this initiative," they said.

## DIRECTOR'S CORNER (A 10-year Retrospective) by Ted Borden

As I look back, down that road that led to where we now stand, I am in awe of the statistics, the numbers; the facts and figures that fill data sheets, grant applications, and accounting forms. There are times when I get caught up in that; when the business side of human services looks larger than the people we serve. In our quest to solve the larger problems of society we often are blinded by the overwhelming demand for proof that a program is financially viable and fiscally sound. These things are of course necessary: checks and balances, accountability boards, and over-site mechanisms. Yet all the statistics of people served, dollars spent, donations received, and programs developed cannot tell the story of success as vividly, as brilliantly, as deeply, as can the hope-filled face of one client.

The community of Teller County created the Aspen Mine Center. It was founded by a small group of committed neighbors and agency representatives led by a force of nature in red Converse All-Stars doubling as an Art Teacher and community activist who daily witnessed the struggles of the children she taught and their families who faced daily challenges like we all do. The idea was simple enough: create a place where people could go to get help finding the answers to questions they had to make their lives, and the lives of their children, better, more stable. Perhaps the greatest indicator that this dream

could be transformed into a tangible reality occurred on Dec. 31, 2001, when the Aspen Mine Casino building was donated free and clear to be used as such a place. As a good friend of the Aspen Mine once exclaimed, "It's incredible that this building could fall from heaven to the earth and land in one piece." That was the first of many miracles to happen in the 100 block of Bennett Ave in Cripple Creek.

One of the most impressive things about the people of Teller County is their commitment to a project that can improve the quality of life. The outpouring of support that occurred to make this "One Stop Shop" resource center a reality was nothing less than inspiring.

We live in one of the most beautiful places on earth, we are connected, all of us, by our commitment to this community and to each other. Let us remember to inspire hope in each other when things look bleak, to inspire the courage to change in each other when we are fearful, and to inspire compassion in each other when we are struggling to forgive.

It is my great honor to have spent the past ten years in service to this community, the neighborhood I love. Whether you are a client or staff member, a volunteer or community service worker, employer or employee, director or custodian, we are, all of us, only one step away from walking in the footsteps of our neighbor... and what a comfort that realization is.

## **GOLDEN CIRCLE NUTRITION PROGRAM RUN BY COMMUNITY OF CARING FOUNDATION**

Since the donated casino building now housing the Aspen Mine Center had a kitchen and dining room, it was a natural fit to host hot lunches for seniors. Such a program began several years ago through a partnership with the Golden Circle Nutrition Program. Hot lunches are served Wednesday and Friday upstairs at the AMC, and Monday, Tuesday and Thursday at the Vicci Center in nearby Victor. Senior Advocate Angie Trelstad oversees the program, working closely with Chef Meeche. Reservations are recommended but not required. Meals for those age 60 and over are \$2.00. A \$6.50 donation is suggested for others. Meals are served from noon to 1:00 but many seniors come much earlier to socialize in the beautiful AMC dining room or charming Vicci Center. Y'all come!

**Bielz and Petri continued:** "The basic reason is to improve the quality of life in our community by offering a safe, reliable transit system for job seekers, senior citizens, the disabled, our youth, and the general population's need for greater access to resources and opportunities. The city of Cripple Creek has submitted an FTA 5311 grant for this expansion and coordinated effort for the benefit of the total local community.

"Currently, a shuttle service plan is being developed between the cities of Cripple Creek and Victor and Community of Caring, under an FTA planning grant with matching funds from the Cripple Creek & Victor Mining Company under Ostrander Consulting firm. The results and finalization of this plan will be released in early September.

"This 3-year extensive groundwork will result in a sustainable, comprehensive, flexible transit system. We believe our travel on this road of coordination and integration of services is the common sense direction for our future. We praise our partners' vision and willing efforts moving this initiative forward!"

### History:

Early in 2009, a two-year \$80,000 Job Access Reverse Commute planning grant was awarded to Community of Caring Foundation to address the issue of transportation in Southern Teller County, with specific concern for the needs of low income job seekers and workers, seniors, the disabled and disadvantaged youth. In April 2011 a preliminary Shuttle Service Plan was developed and coordinated the existing Cripple Creek shuttle with new links to Victor and limited regional connections. This served as the basis for application to the FTA Sec. 5311 Rural Transit Assistance Program.

In January 2012, the Teller County Local Coordinating Council was formalized, with focus on the needs of more than 20 participating agencies. With a second planning grant awarded, the effort is focused on coordinating and developing public and private transit options with other human services providers, by promoting, enhancing and facilitating seamless access to transportation services through an easily accessible coordinated system.

Participating agencies include Community of Caring Foundation, Teller County Salvation Army, Prospect Home Care & Hospice, Cripple Creek & Victor Chamber of Commerce, Southern Teller County Economic Development Coalition, Aspen Mine Center, RE-1 School District, Community Partnership, City of Cripple Creek, City of Victor, City of Woodland Park Economic Development Office, Teller County Government, Teller County Dept. of Social Services, WrapAround House Bill 1451, Teller County Victims Assistance, Pikes Peak Workforce Center, Gold Belt Communities Build a Generation, Victor's DREAM, Triple Crown Casinos, Bronco Billy's, Ramblin' Express, Teller Senior Coalition, In The Lord's Service, The Independence Center, Pikes Peak Area Council of Governments and consultant Transit Plus.
